FULLY UNDERSTAND that: (a) ROWING ACTIVITIES INVOLVE RISKS AND DANGERS of serious bodily injury, including permanent disability, paralysis and death ("Risks"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the Releasees named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the activity.

AGREE AND WARRANT that I will examine and inspect each activity in which I take part as a member of the Club and that, if I observe any condition which consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the activity and will refuse to take part in the activity until the condition has been corrected to my satisfaction.
4. FULLY UNDERSTAND that those participating in activities for crew are transported to Bachelors Barge Club, #6 Kelly Drive, Philadelphia, PA, via their own transportation arrangements. There is no supervision by Bachelors Barge Club for such transportation. Participants must make their own arrangements for transportation to and from the boathouse. The coaching staff and boathouse officials should be advised of any such arrangements, in order solely to coordinate schedules.

HEREBY RELEASE, discharge and covenant not to sue the Bachelors Barge Club, its administrators, directors, agents, officers, volunteers and employees, other participating, regatta organizers, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the activity takes place (each considered one of the Releasees herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which may occur as a result of such claim.
